**(hereafter called the "EXHIBITOR")**

The Buckhorn Community Centre grants the Exhibitor the right to use exhibit space in the exhibition and to demonstrate his/her products on the following conditions:

1. The Exhibitor understands and agrees that by signing and returning this contract and receipt and processing of booth payment by May 31st, 2010 a booth will be reserved for the Exhibitor's use.
2. Booth fees are non-refundable and should be payable to "Buckhorn Community Centre" and are:  
Signed Contract and Payment received by April 30, 2010: \$26.25 (\$25.00 + \$1.25 GST)  
Signed Contract and Payment received after April 30, 2010: \$31.50 (\$30.00 + \$1.50 GST)  
(No post-dated cheques.) Please remit payment and completed contract to The Buckhorn Community Centre, Box 280, Buckhorn, Ontario, K0L 1J0
3. The Exhibitor will hold the Buckhorn Community Centre, its officers, directors, employees and volunteers harmless for any and all damage, expense or liability or any injury or damage to any person, including the general public, the Exhibitor, its agents or employees or to the property of the Exhibitor out of the Exhibitor's participation in Fiesta Buckhorn.
4. The Buckhorn Community Centre will provide tables, tablecloths, one chair, two returnable wineglasses and a token receptacle. **Exhibitors must bring their own signage and Promotional handouts.**
5. **An extension cord (minimum of 25 feet) is to be provided by Exhibitor** if hydro is needed.
6. **COOLERS are to be provided by Exhibitor.** Each exhibitor will receive two (2) bags of ice free of charge. Additional bags will be charged at \$2.50 per to be deducted from exhibitor payout.
7. The Exhibitor retains 70 percent of taste token sales. The Exhibitor agrees to provide 30 percent of taste token sales to the Buckhorn Community Centre for its fund-raising efforts. In addition, any in-booth sales – promotional items, food, accessories – are also subject to the 30% commission to the Buckhorn Community Centre. Exhibitors are expected to provide event organizers with a summary of these sales and a cheque for 30% of sales at the time of check-out, or agree to the 30% to be taken from their final payout.
8. All booths to be set up by 4:00pm. Friday, July 16, 2010. Take down, if required, will not start until the close of the show at 9:00p.m. Exhibitors who run out of product prior to the end of the show will not be allowed to shut their booths until the end of the show at 9:00 p.m. ***There will be a \$50 fine deducted from payout levied on exhibitors who close their booth prior to the end of the show at 9:00 p.m.***
9. Under any Special Occasion Permit allowing sale of alcohol issued by the province, a levy is payable. Expediting that levy is the responsibility of each participating winery or brewery. **Proof of that levy must be brought by Exhibitors providing alcohol.** A copy of the Special Occasion Permit will be provided to each alcohol beverage participant upon check-in at the event.
